Won verdict for homeowner in dispute with neighbor over slip and fall while jump-starting car where Plaintiff required total knee replacement; jury found no negligence on our client and awarded no damages

Won verdict for bridge builder in Dallas, Texas jury trial arising from accident at construction site and alleging permanent brain damage, \$3.1 million dollars sought; Jury placed 100% negligence on Plaintiff after 2 week trial

Successfully Defended Contractor in month-long Arbitration of Construction Defect case with more than \$1 million awarded; no liability on our client
